INTRODUCTION

The General Data Protection Regulation (GDPR), which started on May 25, 2018, provides a modernized compliance framework based on the responsibility for data protection in Europe.

In this context, and in compliance with the determinations contained in this regulation and in with the explanatory note given by the National Data Protection Commission (CNPD), [more info](#), Think Future has taken the following initiatives:

- 1. Information to data subjects:** in compliance with the new rules of the GDPR, all printed, digital and other information texts used were revised and include the additional information required by the GDPR;
- 2. Exercise the rights of data subjects:** Think Future, Ida reviewed internal procedures data holders, including for the purposes of exercising the new rights (provided that the portability and oblivion), in order to ensure compliance formalities provided for in the GDPR;
- 3. Data holders' consent:** Think Future, Ida has implemented a set of procedures that enable it to verify the form, circumstances and terms in which it was and is obtained consent of the data subjects and, if applicable, obtaining new consents;
- 4. Sensitive data:** assessed the categories of personal data processed, in order to identify the possible processing of sensitive data (special categories of data under the GDPR) determined the applicable requirements;
- 5. Documentation and recording of treatment activities:** the activities related to the processing of personal data are documented, either by creating a data processing activities, either through the implementation of internal procedures appropriate;
- 6. Subcontractors contracts:** contracts with subcontractors have been updated to include the set of mandatory information under the GDPR requirements.

7. **Data Protection Officer:** for the necessary cases we've created a specific mail address(rgpd@thinkfuture.pt).

8. **Data treatment security:** Think Future, lda reviewed all policies, practices and internal measures to confirm the level of safety of appropriate data treatment, implementing those that are necessary;

9. **Data protection from design and impact assessment:** Within the scope and context of the was evaluated in the context of the operation of Think Future, lda and its activity, the type of personal data processing designed for the near future, in order to analyze its nature and context, as well as the potential risks to data subjects.

10. **Notification of security breaches:** Think Future, lda shall, when applicable, will report to the competent authorities, the CNPD and data subjects, of any personal data that's considered lost, as well as on a case-by-case basis and in accordance with the criticality of the information involved, the processes used for the detection, identification and investigation of the circumstances of the violation, mitigating measures and information flows between responsible and subcontractor.

6 - Declaring, Exercising or Defending Rights

It may sometimes be necessary to process personal data and, where appropriate and in accordance with local laws and requirements, sensitive personal data in connection with the exercise or defense of rights.
